1. In terms of Rates Circular No. 39 of 2011, the following rates for levy of Terminal Charges were notified and which are valid till 31.03.2012:

S.No.	Commodities	Rate per tonne per terminal
(i)	Iron ore traffic	₹ 45
(ii)	Coal & Food grain	₹ 20
(iii)	All other traffic	₹ 40
(iv)	Container traffic	NIL

2. The matter has been examined and it has been decided by the Board that the existing rates of Terminal Charges as mentioned in the above Para will continue to apply unchanged.
3. These instructions will come into force w.e.f. 01 .04.2012 and will remain valid till 30.06.2012.
4. All other details of Rates Circulars under reference will remain unchanged.
