Sub: Classification of Iron Ore

1. In terms of Rates Circular No. 36 of 2009 and addendum thereto, sanction of the Central Government was accorded for fixation of classification of iron ore and levy of distance based charge on the booking of Iron Ore traffic meant for other than domestic consumption for manufacture of Iron & Steel and Cement.
2. The matter has been reviewed. In continuation of Addendum No. 14 to Rates Circular No. 36 of 2009 dated 01.03.2011, sanction of the Central Government is hereby accorded for revising the existing Distance Based Charge on booking of Iron Ore traffic meant for other than domestic consumption over all distance slabs. Accordingly, the table given in para 1.0 of Rates Circular No. 36 of 2009 may be replaced with the following table:

Distance in KMs	Distance Based Charge
0-200	125% of Base Freight Rate plus ₹1125
201-300	90% of Base Freight Rate plus ₹1125
301-400	75% of Base Freight Rate plus ₹1125
401-500	45% of Base Freight Rate plus ₹1125
501-600	25% of Base Freight Rate plus ₹1125
601-700	10% of Base Freight Rate plus ₹1125
>700	₹1125 only

3. All other terms and conditions as stipulated in Rates Circular No.36 of 2009 will continue to apply unchanged.
4. Monthly appreciation report should be furnished by 7th of the following month for Board's consideration.
5. These instructions will come into force w.e.f. 06.03.2012 and will remain valid till further advice.


