**Sub: Issue of Rates Quotation/Certificate- Charging of fee by
Railways.**

1.0 Instructions were issued vide Board's Rates Circular No. 33 of 2012 on the above cited subject wherein it was advised to levy of charges of ₹ 750/- for issuing the Rates Quotation/Certificate.

2.0 The matter regarding charges applicable on Rates Quotation/Certificate sought by Police/CBI/Courts etc. has been reviewed and sanction of the Central Government is hereby accorded as under:

i. The fee for issuing Rates Quotation/Certificate may not be charged from Police/CBI/Courts in connection with investigation/hearing of Civil/Criminal or any other cases. However, the fee will be charged in case of issuing Rates Quotation/Certificate to the staff of these organizations.

ii. No fee may be charged in Vigilance, Refund and Complaint cases being investigated by Railways.

iii. The fee for issuing Rates Quotation/Certificate may be charged from all other agencies except those mentioned in (i) and (ii) above.

iv. CCMs/CCM (FMs) will have discretionary powers to waive off the fee in specific cases like requests from different Commissions, Parliament or Legislative Secretariat etc.

3.0 This issues with concurrence of Finance Directorate of Ministry of Railways.
