- (c) Instruction contained in Board's letter No. 2011-E(SCT)1/104/1 dated 25/9/2012 (copy enclosed) be adhered to while issuing aforesaid notification; and
- (d) Vacancies against Ex-servicemen quota will be filled up along with the general recruitment.
