

Sub: Levy of Service Tax on Transportation of Goods by Rail.

Ref: Board's Rates Circular No. 29 of 2012.

1. Vide Para No.1 of Rates Circular No. 29 of 2012, guidelines were issued that certain commodities had been exempted from payment of Service Tax as per Ministry of Finance notification No. 25 of 2012 dated 20th June 2012.
2. The matter has been reviewed and Ministry of Finance vide notification No. 3 of 2013 dated 01st March 2013 has omitted items (a)and (e) in entry '20' of Ministry of Finance notification No. 25 of 2012 dated 20th June 2012. Accordingly, Service tax will be leviable on the following commodities:
 - a) *Petroleum and Petroleum Products falling under Chapter heading 2710 and 2711 of the First Schedule to the Central Excise Tariff Act, 1985 (5 of 1986)*
 - b) Household effects
3. These instructions will come into force from **1st April 2013**.
4. This issues with the concurrence of Finance Directorate of Ministry of Railways.


