
SUB: Charging of parcel and Luggage in Premium trains on Dynamic pricing.

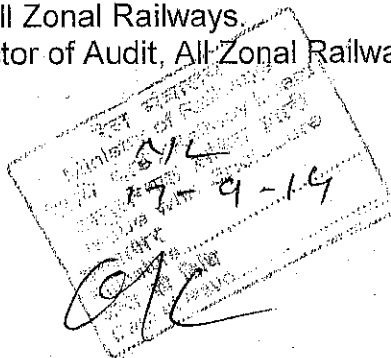




