Sub: Levy of Congestion Surcharge for traffic booked to Bangladesh.

Ref: Board's Rates Circular No. 23 of 2015 and Corrigenda thereto.

1. In terms of Corrigendum to Rates Circular No. 23 of 2015 dated 10.01.2017, it was decided to withdraw the levy of Congestion Surcharge for Stone traffic transported from Eastern Railway to Bangladesh via Darsana/Benapole, as a special case. These instructions are valid up to 31.03.2018 in terms Corrigendum No. 2 to Rates Circular No. 23 of 2015 dated 30.03.2017.
2. The matter has been reviewed and the Competent Authority have decided that the aforesaid instructions shall be extended for a further period of one year i.e. from 01.04.2018 upto 31.03.2019.
3. All other details of the Rates Circular under reference will continue to apply unchanged.
4. This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Ministry of Railways.
