**Sub.:- Updation of ownership details of Privately Owned Wagon in Indian Railway Wagon Management System (IRWMS)- reg.**

A number of requests from private parties regarding change in ownership of privately owned wagons are being received in Board. However, due to non-updation of some of the records, Mechanical Freight Directorate is facing difficulties in dealing with such request.

2. It may be noted that provisions already exist in policy/agreement governing Automobile Freight Train Operator (AFTO), General Purpose Wagon Investment Scheme (GPWIS), Liberalized Special Train Operator (LSFTO) and Container Train Operator (CTO) schemes, for sharing the details of ownership of the wagons (whether purchased or leased from Wagon Leasing Companies).

2.1 Apart from this, as per para 8.3 of Wagon Leasing Scheme (WLS)-2014, jointly authenticated copy of Wagon Leasing Contract executed between Wagon Leasing Company (WLC) as lessor and Operator as Lessee - must include clauses certifying the ownership of the Wagons and is to be shared with IR.

3. Zonal Railway may ensure the compliance of the said provisions.

4. Further, in order to rectify/update the details of owners of the privately owned wagons, Zonal Railways are advised to furnish the following to **Executive Director, Mechanical Engineering (Freight), Railway Board-**

- (a) details of all the privately owned wagons running under above mentioned schemes.
- (b) copy of agreement executed henceforth between operators and IR for induction of rakes under AFTO/GPWIS/LSFTO/CTO, and
- (c) copy of jointly authenticated copy received under the provisions of WLS, clearly specifying the ownership of the wagons

5. This issues in consultation with ME (Freight) and TT Directorates of Railway Board.
