Please refer to Board's letter of even number dtd. 26.06.2025, wherein Zonal Railways were requested to ensure effective utilization of the newly developed feature for online indenting of VPs. It was further requested that Zonal Railways shall keep updating the status of Parcel Offices/ locations/ terminals, notified for handling of Parcel traffic, to CRIS, so as to facilitate the online booking of VPs by customers without any hitch.

In this regard, CRIS vide their e-mail dtd. 17.07.2025 (copy enclosed) has highlighted certain operational issues regarding Parcel locations defined in the VAP module, but the same are not enabled in PMS.

Hence, in order to maintain uniformity across systems, avoid disputes regarding inward traffic, etc. and to ensure seamless online indenting of VPs by customers, CRIS has requested to provide zone-wise consolidated list of all Parcel offices/ locations/ terminals, notified for handling of indented Parcel Trains, in the format detailed in their e-mail.

It is therefore requested that the desired information may be furnished to CRIS urgently, under intimation to this office.

Matter may be treated as MOST IMPORTANT.

Dear FM Directorate.

Initially, we had opened all the goods locations in the FBD portal for Train Indents. Vide Railway Board letter No. 2024/TC(FM)/11/11 dated 26/06/2025, it was instructed:

"Zonal Railways are also requested to keep updating the status of Parcel offices/ Locations/ Terminals, as notified from time to time for handling of Parcel traffic to CRIS, so as to facilitate the online indenting of VPs by customers without any hindrance."

Accordingly, we have been adding locations based on telephonic requests received from Zonal Railways.

However, this has started creating operational issues, as some of the goods locations defined in the VAP module are not enabled in PMS. Additionally, Zonal Railways may question the enablement of stations for inward traffic based on requests received only from the originating zone.

In view of the above, it is requested to provide a consolidated list of all Indented Parcel Train handling stations in the following format to streamline validation across PMS, VAP, and indenting systems:
