Sub: Drawal of House Rent Allowance by husband and wife
when both of them happen to be railway servants
and are living in hired/owned accommodation -
Clarification regarding.

The question of admissibility of house rent allowance to both husband and wife who are railway/Central Govt. servants, in the context of implementation of the recommendations of the Fourth Central Pay Commission, has been examined by the Government in consultation with the Staff Side in the National Council of the JCM.

2. It is clarified that no restriction should be imposed only on the ground that husband/wife is also a Railway/Central Govt. servant and is living in private accommodation, hired/owned by the spouse. In such cases normal amount of house rent allowance may be granted to them, as per entitlement, subject to fulfilment of other conditions for drawal of the allowance.
3. If the Railway/Central Govt. servant is residing in Govt. owned or leased accommodation, which is allotted to him/her as Govt. accommodation, the other spouse will not, however, be eligible to draw house rent allowance, as per the extant orders.
4. This has the approval of the President and issues with the concurrence of the Finance Directorate of the Ministry of Railways.
