**Sub: Dispensation from mandatory weighment in case of Nepal bound containerized import traffic**

Ref: Rates Master Circular/Weighment/2019/0 and its corrigendum

Reference has been received from CONCOR seeking exemption from mandatory weighment in case of Nepal bound containerized Import traffic.

The matter has been examined and it has been decided to permit dispensation from mandatory weighment in case of Nepal bound containerized Import traffic subject to the condition that CONCOR will submit Custom's document to establish weight of containers alongwith Forwarding note and Goods clerk will capture the same in the system(TMS).

Accordingly, following para may be added in the Rates Master Circular/Weighment/2019/0 –

**“3.3.1 Dispensation from mandatory weighment in case of Nepal bound containerized import traffic**

Dispensation from mandatory weighment in case of Nepal bound containerized Import traffic may be permitted subject to the condition that CONCOR will submit Custom's document to establish weight of containers alongwith Forwarding note and Goods clerk will capture the same in the system(FOIS/TMS). The weight of the container is to be added to the Custom's cargo data at the time of feeding of loading details. This procedure will be followed till EDI interface is fully established between Custom's server and CONCOR server. Thereafter, the container details will be transmitted through EDI to FOIS”

This issues in consultation with Traffic Transportation Dte. and with the concurrence of Finance Dte. of Railway Board.
