- 1.0 In terms of Board's letter referred at (i) above, South Western Railway have forwarded proposal with due approval of the General Manager to include the section - Londa – Miraj (LD - MRJ) in the CC+8 routes.
- 2.0 The proposed section Londa-Miraj (LD-MRJ) is already mentioned in Annexure-II of Rates Master Circular under reference at (ii) above, as Expected CC+6 routes. The same may be treated as deleted.
