

- 1.0 In terms of Board's letter referred at (i) above, Western Railway has forwarded proposal with due approval of the General Manager to include the section namely (1) Ex Domestic Container Terminal CONCOR served by Khodiyar (DCCK) to Khodiyar(KHDB), (2) Ex Lakshmibai Nagar (LMNR) to Dr. Ambedkar Nagar and (3) Ex Rau (RAU) to Tihi (TIHI) in the CC+8 routes.
