- 1.0 In terms of Board's letter referred at (i) above, South Western Railway has forwarded proposal with due approval of the General Manager to include the section namely Sasalu(SLU) - Tolahunse(THN)(Both Up & Dn) and Tolahunse(THN) - Amaravathi Colony(AVC) in the CC+8 routes.
- 2.0 Please refer to Annexure III to Rates Master Circular under reference at (ii) above wherein list of CC+8 routes is prescribed. Now, sanction of the Competent Authority is hereby accorded to include section namely Sasalu(SLU) - Tolahunse(THN)(Both Up & Dn) and Tolahunse(THN) - Amaravathi Colony(AVC) in the CC+8 routes.
- 3.0 All other details of the Rates Master Circular & Corrigenda thereto under reference will continue to apply unchanged.
- 4.0 These instructions shall come into effect from 11.07.2019 and shall remain valid till further advice.
