**Sub: Running of freight trains on CC+8 routes.**

**Ref: i) Board's letter No.2018/E&R/1 (8)/4 dated 24.04.2018.**

**ii) Rates Master Circular/PCC/2019/0 dated 16.05.2019 and Corrigenda thereto.**

- 1.0 In terms of Board's letter referred at (i) above, South Central Railway has forwarded proposal with due approval of the General Manager to include the section – Nallapadu–Nadikude (NLPD-NDKD) and Pagidipalli–Nadikude (PGDP-NDKD) in the CC+8 route.
- 1.0 The proposed section Nallapadu–Nadikude (NLPD-NDKD) and Pagidipalli–Nadikude (PGDP-NDKD) are already mentioned in Annexure-II of Rates Master Circular under reference at (ii) above, as CC+6 routes. The same may be treated as deleted.
- 2.0 Please refer to Annexure III to Rates Master Circular under reference at (ii) above wherein list of CC+8 routes is prescribed. Now, sanction of the Competent Authority is hereby accorded to include following route in the list of already identified CC+8 routes:
