- 1.0 In terms of Board's letter referred at (i) above, Eastern Railway have forwarded proposal with due approval of the General Manager to include the section Poradanga – Manigram (PRDG - MGLE), both Up & Dn lines in the CC+8 routes.
- 2.0 Please refer to Annexure III to Rates Master Circular under reference wherein list of CC+8 routes is prescribed. Now, sanction of the Central Government is hereby accorded to include following route in the list of already identified CC+8 routes:
