Sub: Dispensation from mandatory weighment in case of Nut Coke
Ref: Rates Master Circular/Weighment/2019/0 and its amendments

Reference has been received from one of the Zonal Railways to permit dispensation from mandatory weighment in case of Nut Coke as prescribed for Petroleum/Metallurgical Coke.

In terms of Para 3.4 of Rates Master Circular/Weighment/2019/0, guidelines for dispensation from mandatory weighment are prescribed in case of Petroleum/Metallurgical Coke.

The matter has been examined and it has been decided to permit dispensation from mandatory weighment of wagon/rake loaded with Nut Coke, by inserting an additional Para 3.4.1 in Rates Master Circular/Weighment/2019/0, as under:


“3.4.1: Dispensation from mandatory weighment in case of Nut Coke

Dispensation from mandatory weighment of wagon/rake loaded with Nut Coke may be permitted with a proviso that at least 5% of rakes should be subjected to weighment (where sample rake to be selected should be completely random) and as per the guidelines prescribed for Petroleum/Metallurgical coke vide Para 3.4.

These guidelines will be applicable for six months i.e. with effect from 14.06.2024 till 14.12.2024. Zonal Railways will furnish its feedback in October 2024 for review.

This issues in consultation with Traffic Transportation Directorate and with the concurrence of Finance Directorate of Railway Board.




