Sanction of the Competent Authority is hereby accorded to permit loading of POL rakes for two point destination terminals (tank wagons) to POLA and IODT sidings by M/s IOCL from BRPN over LMG division of NFR for availing trainload classification subject to conditions laid down in Para 7.0 of the Rates Master Circular dated 14.07.2016 on Block Rakes/Mini Rake/Two Point Combinations etc./2016/0.

The above combination shall be notified separately as Annexure VI. (as enclosed)

This shall come into force with immediate effect and shall remain in force till further advice.

All other conditions prescribed in the Rates Master Circular dated 14.07.2016 on Block Rakes/Mini Rake/Two Point Combination etc./2016/0 and Corrigenda thereto will remain unchanged.
