In superfession of Board's instructions issued vide Telemax No. TCII/2033/2000/Policy dated 28.11,2001 (Commercial Circular No. 82 of 2001) and existing rules for refund of Security Deposit for booking of Special Coaches and Trains contained in Chapter III & IV of IRCA Coaching Tarfff No. 25, Part I (Vol. I), Ministry of Railways have now decided to enhance the Normal period for claiming of refund of security deposit from the existing limit of 15 days to 6 months (.) For applications submitted after expiry of time limit of 6 months, GMs will have full powers to settle time barred claims for refund of Security deposits in consultation with their FA&CAOs (.) The outer time limit for entertaining such refund claims will be subject to a maximum time frame of three years (.) These instructions will be applicable from the date of Issue (.) Past cases will be decided by the zonal railways based on availability of records (.) The refund will, however, continue to be granted after deducting any amount due from the party (.)
