Sub: Entitlement of travel by Jan Shatabdi Express Trains on Duty/Privilege/Post-Retirement Passes.

Instructions were issued by Establishment Directorate of this office vide letter No. E(W)2000PS5-1/17 dated 17.12.2004(copy enclosed) advising that the number of seats which can be booked against Duty Privilege/Post Retirement Complementary Passes in 2S Class of Jan Shatabdi Express trains shall be same as are available in other Mail/Express trains. In case of Chair Car, the entitlement shall be same as is available in Shatabdi Express trains.

It has been further decided that the earmarking of Duty Pass Quota in 2S class of Jan Shatabdi Express trains may be done away with and the booking in these trains against Duty/Privilege/Post Retirement Complimentary passes in this class will be done against general quota. CRIS has informed that the change required in the software has been carried out to enable Duty/Privilege/Post Retirement complimentary pass holders to book ticket in 2S class of Jan Shatabdi Express trains against general quota just like other Mail/Express trains. In super-session of Board's letters of even no. dt. 31.5.02 and 23.8.02 entitlement for travel in Jan Shatabadi Express Trains will be as under:

(i) First Class/I* 'A' Pass, bolders:

- (a) Entitlement for travel[®] the chair car shall be the same as available in Shatabdi Express Trains.
- (b) An eligible attendant shall be allowed in the second class.
- (c) Number of seats available in second class shall be the same as available in other mail/express trains.
- (d) Widows/senior citizens who are 65 years and above shall be allowed to take a companion/attendant, as the case may be in 2nd class subject to prescribed extend conditions.

(E) Second class ness holders:

(a) Number of seats evailable in 2nd class shall be the same as available in other mail/express trains.

PTOs shell be allowed for travel in Jan Shatabadi Express Trains as in other Shatabadi Express Trains.
