G.S.R. 21(E).—In exercise of the powers conferred by Section 25 of the Cigarettes and other Tobacco Products (Prohibition of Advertisement and Regulation of Trade and Commerce, Production, Supply and Distribution) Act, 2003 (No. 34 of 2003), the Central Government hereby authorises, (i) an officer not below the rank of Ticket Collector of the Commercial Department or an Officer of equivalent rank of the Operating Department; or (ii) an officer not below the rank of Assistant Sub-Inspector of the Railway Protection Force in the Ministry of Railways who shall be competent to act under the said Act.
