In terms of Rates Circular No. 22 of 2019, rebate in freight for movement of various commodities in Privately Owned Wagon has been notified for the period from 01.10.2019 to 30.09.2020.

East Coast Railway has notified an additional unloading point for M/s Hindalco Industries Ltd. for transportation of Alumina in Privately Owned Wagons. The issue has been examined in Board's office and it is advised to include the additional unloading point in Rates Circular No. 22 of 2019 dated 30.09.2019 as under:
