1. In terms of Rates Circular under reference, policy guidelines for Liberalised Automatic Freight Rebate Scheme for traffic loaded in Traditional Empty Flow Directions (TEFD) were issued. This Scheme is operative up to 31.03.2018.
2. The matter has been reviewed. It has now been decided to extend the validity of the Scheme beyond 31.03.2018 for a further period of three months i.e. up to 30.06.2018.
3. All other terms and conditions stipulated in above referred Rates Circular and corrigenda thereto shall remain unchanged.
4. This issues in consultation with Traffic Transportation Directorate and with the concurrence of the Finance Directorate of the Ministry of Railways.
