Ref.: Rates Master Circular/e-RD/2014/0 dt.23.09.2014 and its corrigenda/addendum

In terms of para 12.0 of Rates Master Circular/e-RD/2014/0 dt.23.09.2014, the system of registration of demand for wagons electronically (e-RD) is not applicable in the case of container traffic.

The matter has been reviewed and it has been decided to include container traffic under the system of registration of demand for wagons electronically (e-RD). Accordingly, para 12.0 of Rates Master Circular/e-RD/2014/0 stands modified, as under:
