**Sub: Electronic Transmission of Railway Receipt(eT-RR) - inclusion of Container Traffic**

Ref.: Rates Circular No.02 of 2015 and its Addendum dt.13.03.2018

In terms of para 9.7 of Rates Circular No.02 of 2015, the system of Electronic Transmission of Railway Receipt(eT-RR) is not applicable in the case of container traffic.

The matter has been reviewed and it has been decided to include container traffic under the system of Electronic Transmission of Railway Receipt(eT-RR). Accordingly, para 9.7 of Rates Circular No.02 of 2015 stands modified, as under:

Para No.	Existing Guidelines	Revised Guidelines
9.7	The system of eT-RR will be applicable for the freight traffic originating from one station/siding by a single consignor. It will not be available for traffic originating from more than one station/siding and/or by multiple consignors. It will not be applicable in the case of iron ore and container traffic.	The system of eT-RR will be applicable for the freight traffic (except iron ore) originating from one station/siding by a single consignor. It will also be applicable for container traffic (including multiple Railway Receipts). However, the system of eT-RR will not be applicable for freight traffic originating from more than one station/siding and/or by multiple consignors.

This issues in consultation with Traffic Transportation Dte. and Accounts Dte. and with the concurrence of Finance Dte. of Ministry of Railways.
