Sub: Booking and carriage of Silver anklets/leg chains/silver jewellery/ silver handicrafts in passenger compartment as personal luggage

In continuation of Board's letter of even number dated 9.5.2005 It has been decided that booking and carriage of anklets/leg chains/silver jewellery/ silver handicrafts may be allowed in the passenger compartment with owners as personal luggage in second and sleeper classes also on payment of usual charges for such carriage without any free allowance and fulfillment of terms & conditions laid down in Rule 801 of IRCA Coaching Tariff No.25, Part-I(Vol.-III). Permission for such carriage will be subject to following limits:

<u>CLASS</u>	<u>MAXIMUM LIMIT</u>
Second Class	35 Kgs
Sleeper class	40 Kgs

These items can be carried in brief cases of maximum dimension of 40 cms X 35 cms X15 cms in personal custody.
