No. TCII/2046/07/Development Charge (.) Ministry of Railways have decided to levy 2% development charge on parcel and luggage services with effect from 1.7.2007 to fund Dedicated Freight Corridor (DFC) and the receipts on this account would be part of parcel and luggage earnings (.) Existing leased SLRs, AGCs, Parcel Vans and parcel trains will however continue to run as per agreements entered into by the Railways and shall not attract the development charges for the duration of current agreement (.) However, development charges shall be made applicable to future leasing contracts, which are to be called for after 30.06.2007 (.) This issues with the concurrence of the Finance Directorate of Ministry of Railways (.) Necessary instructions may be issued to all concerned (.) Shukla/Railways (.)
