SUB: Charges for haulage of empty wagons on private account.

Sanction of the Central Government is hereby accorded to revise the charges for haulage of empty wagons on private account. The revised charges are as under :-

i) when hauled by scheduled goods train	Rs.21.00 only per four wheeled wagon per kilometer subject to a minimum of Rs.2100/- (Rupees Two Thousand One Hundred only) for all gauges.
ii) when hauled by special train	Rs.1180/- (Rupees Eleven Hundred Eighty only) per kilometer subject to a minimum of Rs.118000/- (Rupees One Lakh Eighteen Thousand only) per train for all gauges.

If the charges at the rate of Rs.21.00 per kilometer for the actual number of wagons hauled by a special train work out higher than the charges at rates indicated in item (ii) above, the former would be leviable. No supplementary charges will be leviable in addition. These rates will also apply to railway wagons given on hire to outside parties for carrying out alteration to suit loading of their over dimensional consignments.

These charges will come into force from 01.02.2006.
