Sub: Booking of traffic via shortest route.

1.0 In terms of Board's letter No.TCR/1125/2001/2 dated 21.08.2001 (Rates Instruction No.73 of 2001), the following note below Rule 125 (5) of IRCA Goods Tariff No.41 Pt.I Vol.I was inserted:

“ Note- Due to certain operational reasons the shortest route for traffic from South Central Railway to Mangalore via Southern Railway (i.e Palghat-Shoranur) route is temporary closed. In relaxation of Rules 125(1), the freight traffic will be moved by the alternative route but the freight will be charged by the shorter route presently not operational provided the freight charges cover the incremental cost of operation incurred on movement by the longer alternative route. This relaxation is valid upto 30.9.2001 or till the traffic is resumed by the shortest route, which ever is earlier.”

2.0 The matter has been reviewed by Board. It has been decided that the note inserted below Rule 125(5) of IRCA Goods Tariff No.41 Pt.I Vol.I vide Correction slip No.108 dated 9.10.2001 may be deleted with immediate effect.

3.0 The charging will continued to be done in terms of Rule 125 in all such cases.

4.0 This issues with the concurrence of Finance Directorate in the Ministry of Railways.
