Para 2.2- Foodgrains sponsored by Food corporation of India/State Government or their Agencies as per the list in Annexure-I and approved by Zonal Railways/Railway Board or Nonsponsored foodgrain except quota traffic advised by Railway Board.

Para 2.3- Levy sugar for public distribution system or other welfare schemes sponsored by Food corporation of India/State Government or their Agencies as per the list in Annexure-I and approved by Zonal Railways/Railway Board. Proposals for sponsorship of any other commodity by a Central Government Agency will require specific approval of Railway Board.

The above amendment will come into force from 2nd November, 2020.
