Sub: Selection of Investigating Inspectors (Vig.)/Traffic in scale of Rs. 9300-34800/- in Grade Pay Rs.4200/- and in Grade Pay Rs.4600/- in the Vigilance Directorate, Railway Board.

In order to fill up ex-cadre posts of Investigating Inspectors (Vigilance)/Traffic in scale of Rs. 9300-34800/- in **Rs.4200/- and in Grade Pay Rs.4600/-** in the Vigilance Directorate of Railway Board, on deputation basis, it has been decided to hold a selection for forming a panel of four (04) candidates in Grade Pay Rs.4200/- and eleven (11) candidates in Grade Pay Rs.4600/-. Out of the panel of 15 candidates, 12 candidates will be from Traffic/Commercial/Traffic Accounts departments and 3 candidates will be from Railway Protection Force/Railway Protection Special Force.

Eligibility:

(i) For Grade Pay Rs.4600/- (For 11 posts)

Staff working in Traffic/Commercial/Traffic Accounts departments and in Railway Protection Force/Railway Protection Special Force in scale of Rs.9300-34,800/- in Grade Pay Rs.4600/- and one scale below, i.e., in Grade Pay Rs. 4200/-, on a regular basis.

For Grade Pay Rs.4200/- (For 04 posts only)

Staff working in Traffic/Commercial/Traffic Accounts departments in scale of Rs.9300-34,800/- in Grade Pay Rs.4200/- and one scale below, i.e., in Grade Pay Rs. 2800/-, on a regular basis.

- (ii) They should have completed at least five years service in Railways as on 31.03.20013.
- (iii) Staff who have already completed their tenure in Vigilance Organisation of Zonal Railways/Units/Railway Board as Investigating Inspector (Vig.)/Vigilance Inspector is not eligible.
- (iv) The staff should have sound integrity, should not be figuring in any current Vigilance/SPE/DAR case and should not have been imposed any major/minor penalty in any past vigilance case.

The selection will comprise of a written test followed by a viva-voce.

Applications of the eligible volunteers should be duly filled up in the enclosed proforma and submitted through proper channel duly forwarded by their Controlling Officer, to the Zonal Railway/Unit Vigilance Department. **Separate applications for the posts of Investigating Inspector (Vig.)/Traffic in Grade Pay Rs. 4200/- and Grade Pay Rs. 4600/- may be forwarded to this office.**

The Zonal Railway/Unit Vigilance Department shall forward the applications of only eligible volunteers received by the due date, to the Vigilance Directorate of Railway Board along with the current Vigilance/SPE/DAR clearance and the past vigilance history of each applicant. It may be ensured that only the applications of eligible staff having proven integrity are forwarded. The applications received through the Zonal Railway/Unit Vigilance Department will only be entertained.

Zonal Railway/Unit Vigilance Department should also advise the controlling officers about names of candidates whose application has been forwarded to Railway Board, and only such candidates shall be spared by controlling officers so as to enable them to appear in the written test. However, even after the application is forwarded by SDGM/CVO, if a candidate is found not fulfilling the eligibility conditions, then his candidature can be cancelled at any stage.

The last date of receipt of applications from the Zonal Railways/Units in the Board's office is **25.06.2013**. The Zonal Railways/Units may ensure that the applications are forwarded to Board's office before the due date. In case no applications are received by the Zonal Railways/Units, the same may also be advised to this office by the due date. Applications received from the Zonal Vigilance unit after the due date i.e. **25.06.2013** shall not be entertained under any circumstances.
