Resolution under reference lays down the principles for making appointments to Level 17 and Level 16 ex-cadre posts in the Railways and the selection norms to be followed. Empanelment is be done batch wise from amongst the eligible candidates, selecting the best suitable officers through a comprehensive assessment by Ministry of Railways and approved by ACC. Ministry of Railways now proposes to initiate the process for empanelment to Level 17 ex-cadre posts of IRMS for 1987 Exam Batch officers.

- For being considered for empanelment, eligible officers will have to apply for empanelment indicating the following:-
- Top three positions that the officer would like to be considered for (officer will, however, be (i) considered for all positions).
- Description of top five contributions to the organization in lifetime (can given more also). (ii)
- Description of top five contribution that officer will make in the top three positions that the officer is (iii) aspiring for in a given time frame.
- Applications for empanelment to Level 17 ex-cadre posts of IRMS are invited from serving officers of 1987 exam batch belonging to 8 organised services viz. IRAS, IRPS, IRSE, IRSEE, IRSSE, IRSME, IRSS and IRTS and working in Level 15 (HAG) or above posts on regular basis on 01.01.2024.
- The last date of receipt of applications will be 30 days from the date of issue of this letter. Scanned copy of Applications may be sent directly to the Establishment Officer, at email id eorlybd.@railnet.gov.in and need not be routed through proper channel. Applications received after the cut-off date, i.e. 27.10.2023 will normally not be entertained. Applications shall be sent from the official NIC Mail ID of the concerned
- This letter may be given wide publicity amongst all officers of the Railways belonging to the 1987 6. batch of eight Organized Group 'A' services of Indian Railways.
