- (iii) The above ad-hoc promotions may be terminated at any point of time without giving any reason therefor.
- (iv) The above ad-hoc promotion will take effect from the date of assuming the charge of the post.
- (v) The service rendered on above ad-hoc promotion in the grade would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
