In terms of **para-336 ibid**, these officers will be placed **below** the junior-most Direct Recruit IRTS officer of Civil Services Examination (CSE)-2001 batch (*earliest joining on 02.09.2002*), whose seniority position had been circulated vide Board's letter No. E(O)I/2005/SR-6/25 dated 19.06.2008 and **above** the senior-most Direct Recruit IRTS officer of CSE-2002 batch (*earliest joining on 01.09.2003*), whose seniority position will be circulated later.
