- 2. The aforesaid ad-hoc promotion shall be initially for one year or till the post is filled up on regular basis or until further orders, whichever is earlier. The ad-hoc promotion is liable to be terminated at any point of time without giving any reason therefor. The ad-hoc promotion will take effect from the date of assuming the charge of the post of ASO. If official fails to assume the charge of post of ASO within 30 days of issue of this order, the promotion order is liable to be cancelled. If the official refuses the promotion on personal ground, he would not be considered for a period of one year from the date of issue of this order.
- 3. The aforesaid ad-hoc promotion shall not confer any right on the official to continue in the grade of ASO indefinitely or for inclusion in the select list for regular appointment to the grade. The service rendered on adhoc basis in ASO grade would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
- 4. The aforesaid ad-hoc promotion would be subject to outcome of O.A. No. 114/2022 (Rahul Gupta & Ors. vs. MOR), O.A. No. 215/2022 (D. P. Singh & Ors. vs. MOR) before Hon'ble CAT/New Delhi, the SLP(C) No. 30621/2011 (Jarnail Singh & Ors. vs. Lachhmi Narain Gupta & Ors.) and the SLP (C) No. 31288/2017 (All India Equity Forum & Ors. vs. UOI & Ors.) before Hon'ble Supreme Court and any other court case(s) before any court of law in the connected matters.
