- (iii) The service rendered on above provisional/ad-hoc promotion in the grade would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
- (iv) The above provisional/ad-hoc promotions will take effect from the date of assuming the charge of the post.
- (v) The above ad-hoc promotion shall be initially for a period of one year (i.e. upto 30.06.2025) or till the posts are filled up on regular basis or until further orders, whichever is earlier
