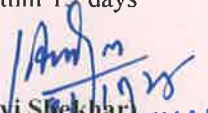

**Subject:** Appointment of Shri Guru Prakash, IRSE in Commission of Railway Safety under Ministry of Civil Aviation- reg.

The Competent Authority has approved the appointment of Shri Guru Prakash (IRSE, DOB:04.07.1969; DITS:27.01.1998), presently on deputation to MRVC as GM (Procurement) to the post of Commissioner of Railway Safety (CRS), Eastern Circle, Kolkata in the Commission of Railway Safety, Ministry of Civil Aviation in Level-15 of the pay matrix, on absorption basis w.e.f. the date of assumption of charge of the post and till the date of his superannuation or until further orders, whichever is earlier.

The competent authority has also accepted technical resignation of Shri Guru Prakash from Railway service, which will take effect from the date of his assumption of charge of the post of CRS in the Commission of Railway Safety, Ministry of Civil Aviation. The appointment of the Commissioner of Railway Safety is governed by the conditions of service in the Commission of Railway Safety.

3. The officer should join the Commission of Railway Safety, Ministry of Civil Aviation within 15 days from the date of issue of this letter in terms of DoP&PW O.M. No. 4/15/88-P&PW(D) dated 13.11.1991. In case, for some reasons, the officer does not join CRS, he should report back to Railway Board within 15 days of issue of this letter.
