**OFFICE ORDER No. 16 OF 2025**

In terms of clause 2(1)(a) of the Schedule to the Railway Board Secretariat Service Rules, 1969, the name of thirteen (13) Assistant Section Officers (ASOs) of Railway Board Secretariat Service(RBSS), were approved by the Competent Authority for inclusion in the Select List for Section Officers' Grade of RBSS [Level-8 in the Pay Matrix] through Seniority Mode, for the vacancy year 2022-23 and for their further regular promotion to said grade. The aforesaid Seniority Mode panel was notified vide Board's Office Order No. 63 of 2024 dated 23.10.2024.

2. Subsequently, Ms. Neha Kumari(D.O.B. 02.02.1987), who has already been promoted to Section Officers' Grade of RBSS on the basis of results of Section Officers' Limited Departmental, Competitive Examination(LDCE)-2022, represented for inclusion of her name in the Select List for Section Officers' Grade of RBSS, for the vacancy year 2022-23 against Seniority Quota instead of LDCE quota. Accordingly, Ms. Neha Kumari was considered for inclusion of her name in the Select List for Section Officers' Grade of RBSS, for the vacancy year 2022-23 through Seniority Quota, by the Review DPC.

3. And, as approved by the Competent Authority, the Seniority Quota panel of Section Officers' Grade of RBSS, for the vacancy year 2022-23, notified vide Board's Office Order No. 63 of 2024 dated 23.10.2024, stands modified, only to the extent mentioned below:-

- (i) The name of Ms. Neha Kumari (**D.O.B-02.02.1987**) is included in the Seniority Quota panel of Section Officers' Grade of RBSS, for the vacancy year 2022-23, at S.No.2A, below the name of Shri Suresh Kumar Gupta (**D.O.B-26.04.1964**) at S.No.2 and above the name of Shri Santosh Kumar (**D.O.B.-12.02.1980**) at S. No. 3; and
- (ii) The name of Ms. Anjana Hore (**D.O.B-29.06.1969**), appearing at S. No.12 in the Seniority Quota panel of Section Officers' Grade of RBSS, for the vacancy year 2022-23, should be deleted.
