OFFICE ORDER No.14 OF 2025

In compliance of Hon'ble Central Administrative Tribunal/New Delhi's judgement dated 31.05.2016 in O.A. No. 591/2009 (in the matter of Shri N.K. Sharma & others Vs UOI) and O.A. No. 2981/2009 (in the matter of Shri Manoj Kumar & others Vs UOI) [both involving the seniority issue between Direct Recruit Section officers and Promotee Section Officers of Railway Board Secretariat Service(RBSS)], the Seniority List of Section Officer's Grade of Railway Board Secretariat Service (RBSS) was revised from 1970 onwards vide Board's Circular No.ERB-I/2012/17/3 dated 29.08.2017, taking into account the principles deliberated in Hon'ble Tribunal's aforementioned order.

- 2. Subsequently, the panels of Grade-I (Deputy Director/Under Secretary) of Railway Board Secretariat Service(RBSS) for the vacancy years 1980-81 to 2010-11 [i.e. the year upto which regular panels of Grade-I(US/DD) of RBSS were earlier framed in consultation with UPSC] were reviewed in consultation with UPSC, on the basis of aforementioned revised seniority list of Section Officers' Grade of RBSS and notified vide Board's Office Order No.50 of 2024 dated 05.08.2024.
- 3. And, in continuation of Review DPC for Grade-I(Under Secretary/Deputy Director) of RBSS, for the years 1980-81 to 2010-11, a DPC proposal for selection of eligible officers for promotion to Grade-I(Under Secretary/Deputy Director) [PB-3 of Rs.15,600-39,100 + G.P. Rs.6,600/- (pre-revised)/Level-11 in the Pay Matrix(7th CPC] of Railway Board Secretariat Service(RBSS) for the vacancy years 2011-12 and 2012-13, was submitted to UPSC vide Board's letter dated 25.11.2024. And, a DPC was convened by UPSC on 17.01.2025 in Commission's office to recommend the panel for promotion to Grade-I (Under Secretary/Deputy Director) of RBSS for the years 2011-12 and 2012-13.
- 4. The following Section Officers' of Railway Board Secretariat Service(RBSS) have been approved by the Competent Authority, in consultation with UPSC, for inclusion in the Select Lists for Grade-I(Under Secretary/Deputy Director) of RBSS for the vacancy years 2011-12 and 2012-13 and for their further promotion to the said grade. Accordingly, they are included in the Select Lists for Grade-I(Under Secretary/Deputy Director) of RBSS for the vacancy years 2011-12 and 2012-13 and promoted to Grade-I of RBSS [PB-3 of PB-3 of Rs.15,600-39,100 + G.P. Rs.6,600/- (pre-revised)/Level-11 in the Pay Matrix(7th CPC] (except those retired/vol. retired/expired/compl. retd. from service, as on the date of issue of this order), in the following order:-

- 5.1. Officers getting empanelled to Grade-I(US/DD) of RBSS in later years or not empanelled in the above revised panels, as compare to their original panels, no recovery in pay/pension will be made, as they have shouldered higher responsibilities of Grade-I(US/DD) from earlier dates/years.
- 6. The inclusion of the aforementioned officers in the Select Lists for Grade-I(Under Secretary/Deputy Director) of RBSS for the vacancy years 2011-12 and 2012-13, and their promotion to said Grade on regular basis, shall be subject to outcome of following court cases:
