**Following promotion/transfer/posting is ordered with immediate effect:-**

On being empanelled for ad-hoc promotion to Principal Private Secretary (PPS) Grade of Railway Board Secretariat Stenographers Service (RBSSS) [Level-11 in the Pay Matrix], Ms. Ruby Dua, Private Secretary (PS) Grade officer of RBSSS, is promoted to PPS Grade of RBSSS on ad-hoc basis and posted as PPS/Dir./E(G), Railway Board.

2. The aforesaid ad-hoc promotion is subject to the following conditions:-

- (i) The above ad-hoc promotion shall not confer any right to continue in the grade indefinitely or for inclusion in the Select List for regular appointment to the grade of RBSSS for which orders are issued.
- (ii) The above ad-hoc promotion shall be initially for a period of one year (i.e. upto 30.06.2025) or till the posts are filled up on regular basis or until further orders, whichever is earlier.
- (iii) The above ad-hoc promotion may be terminated at any point of time without giving any reason therefor.
- (iv) The above ad-hoc promotion will take effect from the date of assuming the charge of the post.
- (v) The service rendered on above ad-hoc promotion in the grade would not count for the purpose of seniority in that grade or for promotion to the next higher grade.

The above ad-hoc promotion is subject to further orders that may be passed by the Hon'ble Supreme Court of India in the Jarnail Singh batch of cases (Civil Appeal No.629 of 2022 arising out of SLP(C) No. 30621/2011); W.P.(C) No.11087/2015 (UPSC Vs. Satish Kumar Gupta & Ors.) before Hon'ble High Court of Delhi and any other court case(s) in the connected matter.
