If any official fails to assume the charge of the post of SSA within 30 days of issue of this order, the promotion order is liable to be cancelled. The officials who refuse the promotion on personal ground would not be considered for a period of one year from the date of issue of this order.

- 3. The aforesaid ad-hoc promotion shall not confer any right on the officials to continue in the grade of SSA indefinitely or for inclusion in the select list for regular appointment to the grade. The service rendered on ad-hoc basis in SSA grade would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
- 4. The aforesaid ad-hoc promotion would be subject to outcome of O.A. No. 114/2022 (Rahul Gupta & Ors. vs. MOR), O.A. No. 215/2022 (D. P. Singh & Ors. vs. MOR) before Hon'ble CAT/New Delhi, the SLP(C) No. 30621/2011 (Jarnail Singh & Ors. vs. Lachhmi Narain Gupta & Ors.) and the SLP (C) No. 31288/2017 (All India Equity Forum & Ors. vs. UOI & Ors.) before Hon'ble Supreme Court and any other court case(s) before any court of law in the connected matters.
