The ad-hoc promotion is liable to be terminated at any point of time without giving any reason therefor. The ad-hoc promotion will take effect from the date of assuming the charge of the post of PA. If any official fails to assume the charge of the post of PA within 30 days of issue of this order, the promotion order is liable to be cancelled. The officials who refuse the promotion on personal ground would not be considered for a period of one year from the date of issue of this order.

The service rendered on ad-hoc basis in PA grade would not count for the purpose of seniority in that grade or for promotion to the next higher grade.

The aforesaid ad-hoc promotion would be subject to outcome of the SLP(C) No. 30621/2011 (Jarnail Singh & Ors. vs. Lachhmi Narain Gupta & Ors.) and the SLP (C) No. 31288/2017 (All India Equity Forum & Ors. vs. UOI & Ors.) before Hon'ble Supreme Court and any other court case(s) before any court of law in the connected matters.
