- Shri Sachin Sharma, who is presently working in NER, should note that for availing this promotion he has to join back in the cadre within 30 days from the date of issue of this order failing which, it shall be presumed that he is not interested in availing of this ad-hoc promotion, and further necessary action shall be taken accordingly.
- The provisional promotion is subject to the following conditions:
- The above ad-hoc promotion shall be initially for a period of one year or till the posts are filled up on regular basis or until further orders, whichever is earlier.
- The ad-hoc promotion shall not confer any right on the officer to continue in the Senior (ii) Translation Officer Grade indefinitely or to claim seniority in the grade of STO. The service rendered on ad-hoc basis in the Senior Translation Officer Grade would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
- (iii) The above ad-hoc promotion is liable to be terminated at any point of time without giving any reason thereof.
- (iv)The above ad-hoc promotion shall take effect from the date of assuming the charge of the post of Senior Translation Officer.
- If any official fails to assume the charge of post of Senior Translation Officer within 30 (v) days of issue of this order, without the prior approval of the Competent Authority for extension in joining time, his/her promotion would automatically stand cancelled.
- If any official refuses promotion on personal ground, he/she would not be considered for (vi) promotion for a period of one year from the date of issue of this promotion order.
- The aforesaid ad-hoc promotion would remain subject to the outcome of the SLP(C) No 30621/2011 (Jarnail Singh &Ors. Vs. Lachhmi Narain Gupta &Ors.) and the SLP(C) No.31288/2017(All India Equity Forum &Ors. Vs. UOI &Ors.) and any other Court case(s). before any Court of Law in a connected matter.
