2. The aforesaid ad-hoc promotion shall be initially for one year or till the posts are filled up on regular basis or until further orders, whichever is earlier. The ad-hoc promotion is liable to be terminated at any point of time without giving any reason therefor. The ad-hoc promotion will take effect from the date of assuming the charge of the post of PA. If any official fails to assume the charge of the post of PA within 30 days of issue of this order, the promotion order is liable to be cancelled. The officials who refuse the promotion on personal ground would not be considered for a period of one year from the date of issue of this order.

3. The aforesaid ad-hoc promotion shall not confer any right on the officials to continue in the grade of PA indefinitely or for inclusion in the select list for regular appointment to the grade. The service rendered on ad-hoc basis in PA grade would not count for the purpose of seniority in that grade or for promotion to the next higher grade.
