I. COMPANY PROFILE

IRCON was incorporated under the Indian Companies Act, 1956 with the objective to carry on construction activities basically in Railways (subsequently diversified in all spectrum of infrastructure sector) including turnkey projects under Build, Operate and Transfer (BOT), Build, Lease and Transfer (BLT), Build, Own, Operate and Transfer (BOOT) or any other scheme. The mission of the company is to be recognized nationally and internationally as a specialized construction organisation comparable with the best in the field covering the entire spectrum of construction activities and services in the infrastructure sector. IRCON is a Schedule – “A” Miniratna CPSE with the administrative jurisdiction of Ministry of Railways.

The company employed 1123 regular employees (Executives : 774, Non-executives: 349) as on 31.03.2020.

The authorized and paid up capital of the Company were Rs. 400 crores and Rs. 94.05 crores respectively as on 31.03.2020.

Its Registered and Corporate office are at New Delhi.

The shareholding of the Government of India in the company is 89.18% as on 31.03.2020.

II. JOB DESCRIPTION AND RESPONSIBILITIES

The Chairman & Managing Director is the Chief Executive of the Corporation and is accountable to the Board of Directors and Government. He/She is responsible for the efficient functioning of the

Corporation, and for achieving its corporate objectives and performance parameters.

III. ELIGIBILITY

Preference would be given to candidates from listed Companies.

(* The average audited annual turnover of three financial years preceding the calendar year in which the post is advertised shall be considered for applying the approved limits)

3. QUALIFICATION:

Applicant should be a graduate with good academic record from a recognized University/ Institution.

Applicants with Technical/MBA qualifications will have added advantage.

4. EXPERIENCE:

Applicants should possess adequate experience at a senior level of management in a large organization of repute.

Applicants with experience in Finance/ Marketing/ Production/Projects will have added advantage.

Experience of infrastructure projects, especially railway projects, is desirable.

6. CONDITION OF IMMEDIATE ABSORPTION FOR CENTRAL GOVERNMENT OFFICERS

Central Government Officers, including those of the Armed Forces of the Union and the All India Services, will be eligible for consideration only on immediate absorption basis.

IV. DURATION OF APPOINTMENT

The appointment shall be for a period of five years from the date of joining or upto the date of superannuation or until further orders, whichever is earlier.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE other than the one to which the candidate belongs.

3. For candidates from SPSE/ Private Sector

a. If a candidate conveys his/her unwillingness to join after the interview is held, he/she would be debarred for a period of two years from the date of interview, for being considered for a Board level post in any CPSE.

b. Further, if a candidate conveys his/her unwillingness to join after the issue of offer of appointment, he/she would be debarred for a period of two years from the date of offer of appointment for being considered for a Board level post in any CPSE.
