It is proposed to fill up one post of Member (Finance) in Inland Waterways Authority (IWAI), NOIDA, U.P. by transfer on deputation basis for a period of 3 years which can be extended up to 5 years. The post is in the Level 14 (in the pre-revised Pay Band – 4 (Rs. 37,400 –Rs. 67,000) + Grade Pay of Rs. 10,000/-).

2. Member (Finance), Inland Waterways Authority of India will be responsible for:-

(i) Tendering financial advice as per General Financial Rules and other financial procedures/discipline prescribed by the Ministry of Finance and in maintenance of accounts of the Authority.

(ii) His duty and responsibility will include evaluation of the schemes prepared by the Engineering/Technical Wing of IWAI, rendering proper financial advice, enforcing financial discipline in expenditure, formulation of budget, plan provisions, introduction of transparency in accounting system, submitting balance-sheet in time to the Authority and rendering financial advice on matters as are assigned to him from time by the Authority.

3. As a member of Authority, Member (Finance) will be entitled for accommodation as per IWAI policy.
