Others	One scale higher than parent grade or deputation allowance if posted in same grade are permissible. Railway accommodation, TADK or Care Taker allowance, Liberal lease facility including Self Lease, Conveyance Allowance/Official vehicle, Liberal medical facilities, Soft furnishing allowance, electricity allowance etc. are also available. Applications received through proper channel and with verification of service particulars, SPE/D&AR/VIGILANCE clearance and enclosure of APARs will be preferred. However a copy of application may also be sent by the applicant in advance to RLDA.

Applications received after closing date and time shall not be entertained. On selection, the applicants will be allowed to join RLDA after receipt of vigilance/ D&AR clearance, and releasing by parent office.
